

PRIVACY POLICY



General

On the 25th May 2018, the current Data Protection Act is being replaced by the new General Data Protection Regulations (GDPR) that applies to all companies and societies using personal data. This requires us by UK/EU law to get your permission to hold information about you and to let you know how it will be used. This document states the privacy policy of Maggie Gallagher.

It is Maggie's policy to ensure that any personal data supplied is kept private and secure at all times and treated in the strictest of confidence.

We do not gather any visitor information on the website – information related to our mailing list and other enquiries is separately handled via email using the email addresses published on the Contact Us webpage. Mailing list information is not held on the website and is not held without your express permission in accordance with the UK/EU GDPR.

Please read the following privacy policy to understand how we collect and use your personal data, for example when you contact us, visit our website or Facebook, or apply to be added to the Mailing List that keeps you up to date with Maggie Gallagher.

Whenever you give us personal data, you are consenting to its collection and use in accordance with this privacy policy.

What personal data do we collect?

We may collect personal data, such as your name, email address, telephone and/or mobile number when you wish to be added to the Mailing List via a request using the email address published on the Contact Us webpage. We may also retain your email address for the purpose of handling your enquiries.

None of this information is held on this website. All personal information is only stored on a home computer, phone or mobile device and is password protected. This is required by UK/EU law. No paper copies are held.

How do you use my personal data?

If you provide personal data to us, we will collect that information and use it for the purposes for which you have provided it and in accordance with this privacy policy.



Browsing our site

Whenever you connect to our website, we do not collect any information related to your visit.

Cookies

A cookie consists of a piece of text that gets entered into the memory of your web browser by a website, allowing the website to store information on your machine for later retrieval. The information is sent back to the website each time the browser requests a page from the website. This mechanism enables the website to identify and track your web browser.

We do not use any cookies or analytics to gather personal information on our website or to track your browser.

Mailing List

Any stored personal information (i.e. forename, surname, email address, telephone and/or mobile number) that Maggie Gallagher and Keeley Middleditch (on behalf of Maggie Gallagher) hold is used solely by Maggie Gallagher and Keeley Middleditch and is not shared with anyone else. Phone numbers are held as a point of contact between yourself and Maggie Gallagher/Keeley Middleditch as and when the needs arise. Email address and telephone/mobile numbers are used to provide up-to-date information.

Dance Holidays and Weekend Events

Our website provides only limited information about forthcoming dance holidays and weekend events. Links are provided on the Events webpage to the external websites that have more detailed information and booking information. You may also request further information via the emails and links detailed on the Contacts Us webpage. Further correspondence will be via email with the parties that you contact. We do not use email to notify you of such events but may provide up-to-date information when required.



Email communications

We adhere to the following guidelines in relation to our email communications:

- emails will clearly identify us as the sender – see addresses on the Contact Us webpage;
- you may unsubscribe from the mailing list at any time
- any third parties who send emails regarding our dance holidays and weekend events will be required to comply with legislative requirements on unsolicited emails and the use of personal data;

If you receive an email which claims to come from us but does not use this address or any published on the Contacts Us webpage, or if you are suspicious that an email may not be approved by us, then please send a copy of the email to maggieginfo@aol.co.uk so that we can investigate.

With whom might we share your personal data?

We do not share your personal data with any third parties for marketing purposes. You are responsible for personally contacting other organisations via the links and emails provided on our website for information, products and services that you require, such as dance holidays and weekend events.

The organisations that you contact are responsible for taking all reasonable steps to ensure that your personal data is treated securely and in accordance with their privacy policy.
